

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.brookmaesalon.com, and BROOK MAE, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to BROOK MAE, LLC include www.brookmaesalon.com and Brook Mae Salon. The Brook Mae Salon website is a salon and ecommerce site. By using the Brook Mae Salon website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, Brook Mae Salon may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase Brook Mae Salon's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. These may include: (a) registering for an account; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

Use of your Personal Information

Brook Mae Salon collects and uses your personal information to operate and deliver the services you have requested.

Brook Mae Salon may also use your personally identifiable information to inform you of other products or services available from Brook Mae Salon and its affiliates.

Sharing Information with Third Parties

Brook Mae Salon does not sell, rent or lease its customer lists to third parties.

Brook Mae Salon may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party.

Brook Mae Salon may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. Tracking User Behavior

- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
- Otherwise use your personal information, internally, in a lawful manner that is

compatible with the context in which you provided the information.
